- C&H hereby acquires from Uncommon the rights to the name Fresh Again[®], the formulas, customer lists, supplier lists and sourcing information, the manufacturing techniques and manufacturing equipment specific to or needed for the task of producing the Fresh Again[®] line, the portion of the Uncommon internet web site devoted to Fresh Again[®], the registrations of the products and names for the Fresh Again line including but not limited to patents, trademarks, and copyrights, and the sales literature related to Fresh Again[®] products including brochures, advertising materials and trade show supplies.
