**PARTIAL TERMINATION OF SECURITY INTEREST**  
**(Trademarks and Patents)**

This Partial Termination of Security Interest is made and entered into as of the 26<sup>th</sup> day of June, 1995, by and between Blue Coral, Inc., a Delaware corporation ("Blue Coral") and National City Bank, a national banking association organized under the laws of the United States of America, as agent pursuant to the Credit Agreement referenced below ("NCB Agent").

**Preliminary Statements:**

A. Blue Coral, National City Bank on its own behalf ("NCB"), Society National Bank ("SNB" and, together with NCB, collectively the "Banks") and NCB Agent entered into a Credit Agreement dated August 18, 1994 (the "Credit Agreement"), pursuant to which the Banks have agreed to advance certain credit facilities to and for the benefit of Blue Coral.

B. In order to partially secure Blue Coral's obligations to the Banks pursuant to the Credit Agreement, Blue Coral granted NCB Agent a security interest in and to, among others, the trademark and patent rights and applications owned by Blue Coral and listed on Exhibit A attached hereto (the "Collateral").

C. Blue Coral has agreed to sell, among other assets, the Collateral to Namico, Inc., a Pennsylvania corporation, pursuant to the terms of an Asset Purchase Agreement dated June 22, 1995.

D. Blue Coral has requested and the Banks and NCB Agent have agreed to release the security interest of NCB Agent in and to the Collateral.

E. The parties desire to enter into this Agreement for the purpose of evidencing the termination and release of the security interest of NCB Agent in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereto agree as follows:

1. NCB Agent hereby releases and terminates its security interest in and to the Collateral.

2. Blue Coral is hereby authorized to file a copy of this Partial Release and Termination with the United States Department of Commerce Patent and Trademark Office.

3. This Partial Release and Termination shall be governed by and construed in accordance with the laws of the United States and, to the extent not inconsistent therewith, the State of Ohio.
