TERMINATION AGREEMENT

This **TERMINATION AGREEMENT** made as of the 15th day of July, 1998 by and between **MELLON BANK, N.A.**, a national banking association with an address at 610 West Germantown Pike, Suite 200, Plymouth Meeting, PA 19462 ("Bank"), and **NAMICO, INC.**, a Pennsylvania corporation with an address at 4601 Flat Rock Road, Philadelphia, PA 19127 ("Borrower").

WITNESSETH:

WHEREAS, Bank and Borrower have entered into a Loan and Security Agreement dated June 26, 1995 (as amended to the date hereof, the "Loan Agreement") pursuant to which Bank extended certain credit facilities to Borrower; and

WHEREAS, Borrower and Bank have entered into an Assignment of Rents and Leases dated as of June 26, 1995 (the "Rents Assignment") securing Borrower's indebtedness to Bank pursuant to the Loan Agreement; and

WHEREAS, Borrower has executed a Collateral Assignment of Rights dated June 26, 1995 (the "Rights Assignment") in favor of Bank securing Borrower's indebtedness to Bank pursuant to the Loan Agreement; and

WHEREAS, Borrower and Bank have entered into a Collateral Assignment of Patents, Trademarks, Licenses and Copyrights dated as of June 26, 1995 (the "Patents Assignment") and recorded on July 10, 1995 in the records of the United States Patent and Trademark Office (the "USPTO") at Reel 1371/Frame 567, securing Borrower's indebtedness to Bank pursuant to the Loan Agreement; and

WHEREAS, on July 1, 1998, Borrower repaid to Bank all obligations of Borrower under the Loan Agreement, other than certain potential obligations of Borrower under letters of credit which have been separately collateralized; and

WHEREAS, in connection with such payoff, Bank has terminated all collateral liens held to secure such obligations and has agreed, among other things, to execute this Termination Agreement to evidence the release of such liens.

NOW, THEREFORE, in consideration of the foregoing provisions and of other good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound, the parties hereto covenant and agree as follows:

The Rents Assignment, the Rights Assignment and the Patents Assignment are hereby terminated and rendered null and void by the agreement of the parties hereto and shall hereafter have no further force and effect, and the record thereof in the USPTO may be marked accordingly at the direction and expense of Borrower.

IN WITNESS WHEREOF, the parties hereto have caused this termination Agreement to be executed as of the day and year first above written.
