Upon the request of the Assignee, the Assignor shall, at Assignee's sole cost and expense, at any time and from time to time, execute, acknowledge, deliver and perform all such further acts, deeds, assignments, transfers, conveyances, powers of attorney and instruments of further assurances as may be necessary to assist or enable Assignee to obtain and enforce full benefits upon the rights and interests herein assigned. Assignor agrees to waive all rights and privileges to attack the registration of the Marks.
