1. Apparel America, Inc. (hereinafter referred to as the "Corporation") is a business corporation of the State of Delaware.

2. The Corporation is the owner of all of the outstanding shares of the stock of Robby Len Fashions, Inc., which is also a business corporation of the State of Delaware.

3. On January 30, 1989, the Board of Directors of the Corporation adopted the following resolutions to merge Robby Len Fashions, Inc. into the Corporation:
