## ASSIGNMENT OF TRADEMARK


WHEREAS, **Zane W. This Assignment includes the right to apply for registration of the Mark in any and all jurisdictions where such registration is desired by Assignee, the right to renew any registration which may issue for such Mark, and the right to claim for any and all damages by reason of past infringement of the Mark, and the right to sue for and collect the same for ASSIGNEE's own use and enjoyment and for the use and enjoyment of its successors and assigns.
