**ASSIGNMENT OF TRADEMARKS**

Capitalized terms used without definition in this Assignment shall have the meaning assigned to such term in the Purchase Agreement.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee all of Assignor's rights, title and interests in and to all trademarks, service marks, trade dress, logos and trade names, together with all translations, adaptations, derivations and combinations thereof, and all applications, registrations and renewals in connection therewith, related to or in connection with the Acquired Assets other than the Retained Trademarks (collectively, the "Trademarks"), including, without limitation, the Trademarks listed in Exhibit I hereto (collectively, the "Assigned Trademarks"). The Assigned Trademarks are being assigned free and clear of any security interests, claims, liens, pledges, options, encumbrances, charges, agreements or other arrangements, restrictions or limitations of any kind.

From time to time after the Effective Date, at the request of Assignee, Assignor will execute and deliver to Assignee all such assignments, endorsements and other documents, and take such other action as Assignee may reasonably request, in order to more effectively transfer and assign to Assignee the Assigned Trademarks, to confirm the title of Assignee thereto, and to assist Assignee in exercising its rights with respect thereto.

This Assignment is made pursuant to and is governed by the Purchase Agreement, with all representations, warranties, covenants and indemnifications, together with limitations if any thereon, set forth in the Purchase Agreement to apply hereto and incorporated herein by reference.

This Assignment shall be binding upon and inure to the benefit of the parties to it, their heirs, executors, administrators, permitted successors and permitted assigns.

This Assignment shall be governed by and construed in accordance with the laws of the State of California without giving effect to principles of conflict of laws.

This Assignment may be executed by a party's signature transmitted by facsimile, and copies of this Assignment executed and delivered by means of facsimile signatures shall have the same force and effect as copies hereof executed and delivered with original signatures. All parties may rely upon facsimile signatures as if such signatures were originals. Any party executing and delivering this Assignment by facsimile shall promptly thereafter deliver a counterpart signature page of this Assignment containing said party's original signature.
