Release of Lien on Trademarks

WHEREAS, pursuant to the Security Agreement dated as of January 31, 2002, among The Meow Mix Company ("Debtor"), the guarantors party thereto and UBS AG, Stamford Branch, as collateral agent (the "Agent") (as amended, the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office on April 7, 2003 on reel 002706, frame 0586, Debtor granted to the Agent a security interest in and lien on, among other things, the Trademark Collateral;

The Agent hereby agrees, at Debtor's expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of its security interest in and lien on the Trademark Collateral.






