3. The name of the surviving limited liability company is Pettibone Michigan, L.L.C., a Delaware limited liability company.

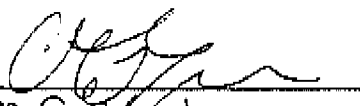
4. The executed Agreement of Merger is on file at the principal office of the surviving limited liability company at 1100 Superior Avenue, Baraga, MI 49908.
