ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

OF

LINDSEY MORDEN CLAIM SERVICES, INC.

FILED In the Office of the Secretary of State of Texas FEB 18 1999 Corporations Section

Pursuant to the provisions of Art. 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE. The name of the corporation LINDSEY MORDEN CLAIM SERVICES, INC.

ARTICLE TWO. The following amendment to the Articles of Incorporation was adopted by a vote of the shareholders and the Board of Directors of the corporation on February 10 and February 11, 1999:

By striking out the whole Article FIRST thereof as to now exists and inserting in lieu and instead thereof a new FIRST Reading as follows:

"FIRST: The name of the corporation is CUNNINGHAM LINDSEY U.S. INC. (hereinafter called the "Corporation")"

ARTICLE THREE. The number of shares of the corporation outstanding at the time of such adoption was 998,842 and the number of shares entitled to vote thereon was 998,842. The number of shares voting for the Amendment was 998,842 and no shares voted against it.

ARTICLE FOUR. This Amendment shall be effective on March 1, 1999.
