MEMORANDUM OF TRADEMARK AND SERVICE MARK SECURITY INTEREST

This Memorandum of Trademark and Service Mark Security Interest, dated as of April 5, 2004, is among Crowley Foods, LLC, a Delaware limited liability company ("Crowley"), having a place of business at 95 Court Street, Binghamton, New York 13901, Rosenberger's Dairies, LLC, a Delaware limited liability company ("Rosenberger"), having a place of business at 847 Forty Foot Rd., Hatfield, Pennsylvania 19440, Kemps Foods, LLC, a Delaware limited liability company ("Kemps"), having a place of business at 1801 Hampstead Road, Lancaster, Pennsylvania 17601, Heluva Good LLC, a Delaware limited liability company (collectively with Crowley, Rosenberger and Kemps, the "Mark Owners"), having a place of business at 6551 Pratt Road, Sodus, New York 14551, and Fleet National Bank, as agent (the "Secured Party") under the Guarantee and Security Agreement (as defined below), having a place of business at 100 Federal Street, Boston, Massachusetts 02110.

1. Pursuant to the Amended and Restated Guarantee and Security Agreement dated as of April 5, 2004, as amended and in effect from time to time (the "Guarantee and Security Agreement"), among HP Hood LLC, a Delaware limited liability company, its subsidiaries from time to time party thereto, including the Mark Owners, and the Secured Party, the Mark Owners have granted to the Secured Party a security interest in certain trademarks, service marks and applications therefor listed in Exhibit A attached hereto and made a part hereof, in the respective names of the Mark Owners, together with the registrations thereof and goodwill symbolized thereby (collectively, the "Collateral").

2. The Mark Owners are the exclusive owners of all rights in the Collateral, including all rights to prosecute for unconsented use and infringement thereof. The Mark Owners have the capacity to grant to the Secured Party the security interests granted under the Guarantee and Security Agreement.






