SECURITY INTEREST (TRADEMARKS)

This RELEASE OF SECURITY INTEREST (TRADEMARKS) (this "Release") is granted on this 18<sup>TH</sup> day of May, 2004 (the "Effective Date"), by Bank of America, N.A., a national banking association, having an office at 335 Madison Avenue, New York, NY 10017, as agent for the lenders (in such capacity as agent, "Assignor"), to Con-X Corporation, an Alabama corporation, with its principal office at c/o Krone Inc., 7229 South Alton Way, Centennial, CO 80112 ("Assignee"), as follows:
