It is hereby certified that:

1. Amadeus NMC Holding, Inc. (hereinafter sometimes referred to as the "Corporation") is a corporation of the State of Delaware.
2. The Corporation is the owner of all of the outstanding shares of common stock of E-Travel, Inc., which is a corporation of the State of Delaware.
3. On December 31, 2003, the Board of Directors of the Corporation adopted the following resolutions to merge e-Travel, Inc. into the Corporation:

**WHEREAS**, the Corporation owns all of the issued and outstanding capital stock of e-Travel, Inc., a Delaware corporation (the "Subsidiary"); and

**WHEREAS**, the Board of Directors deems it advisable and in the best interests of the Corporation that the Subsidiary be merged with and into the Corporation, with the Corporation being the surviving corporation, effective as of January 1, 2004 (the "Merger") for accounting purposes only, pursuant to Section 253 of the Delaware General Corporation Law;

**NOW, THEREFORE, IT IS RESOLVED** that, effective as of January 1, 2004, for accounting purposes only, the Subsidiary shall be merged with and into the Corporation and all of the estate, property, rights, privileges, powers, and franchises of the Subsidiary shall be vested in and held and enjoyed by the Corporation as fully and entirely and without change or diminution as the same were before held and enjoyed by the Subsidiary in its name;

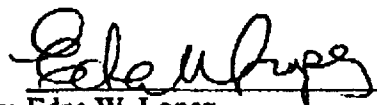
**RESOLVED FURTHER**, that the Corporation shall assume all of the obligations of the Subsidiary;

**RESOLVED FURTHER**, that the Corporation shall cause to be executed and filed and/or recorded the documents prescribed by the laws of the State of Delaware, and by the laws of any other appropriate jurisdiction and will cause to be performed all necessary acts within the jurisdiction of organization of the Subsidiary and of the Corporation and in any other appropriate jurisdiction.

4. The merger of e-Travel, Inc. into the Corporation pursuant to this Certificate of Ownership and Merger shall be effective on January 1, 2004., for accounting purposes only.
