ASSIGNMENT AGREEMENT

ASSIGNMENT AGREEMENT (this "Assignment"), dated as of January 1, 2004, by and between Amadeus NMC Holding, Inc., a Delaware corporation ("Amadeus NMC"), and Amadeus North America LLC, a Delaware limited liability company ("Amadeus") (Amadeus NMC and Amadeus, collectively, the "Parties").

RECITALS:

WHEREAS, the Board of Directors of Amadeus NMC have authorized and approved the transfer of certain assets of Amadeus NMC (formerly held by e-Travel, Inc) listed on Exhibit A hereto (the "Assets") to Amadeus; and

WHEREAS, Amadeus NMC and Amadeus desire to enter into this Assignment to effect such transfer of the Assets;

NOW, THEREFORE, Amadeus NMC hereby transfers, conveys, assigns and delivers to Amadeus all of Amadeus NMC's right, title and interest in and to all of the Assets, to have and to hold unto Amadeus and its successors and assigns forever. Amadeus does hereby assume and agree to pay, perform and discharge promptly and in full when due all of Amadeus NMC's obligations under the contracts and agreements assigned to Amadeus hereunder.

The assignment of the Assets contemplated hereby shall be effective as of 12:01 a.m. January 1, 2004 (the "Effective Date"). The value of all Assets shall be the book value as of the Effective Date.


With respect to any Asset or any claim, right or benefit arising thereunder or resulting therefrom that requires the consent of any third party for the assignment thereof to Amadeus promptly after the date hereof, Amadeus NMC and Amadeus shall use all reasonable efforts to obtain any such consent or written confirmation from such parties that such consent is not required. In the event any required consent for a particular Asset is not obtained, then the assignment of such Asset shall be deemed null and void.

Amadeus NMC shall execute and deliver such further instruments of transfer, conveyance and assignment and take such other actions as may be reasonably necessary in order effectively to dividend, distribute, grant, contribute, transfer, convey and assign to and vest in Amadeus all of Amadeus NMC's right, title and interest in and to the Assets as specified herein.


This Agreement shall be construed and interpreted in accordance with the laws of the State of Florida without regard to its choice of law provisions.
