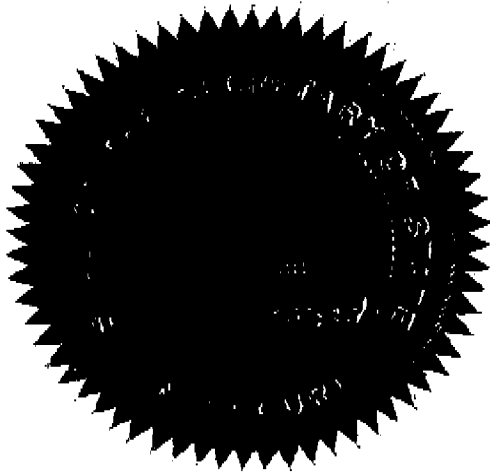

Pursuant to the provisions of R.S. Mo. §§ 347.700 through 347.740, the undersigned entities certify the following:

1. That Interim Mayflower Transit II, LLC, a Missouri limited liability company ("Mayflower"), and Mayflower Transit, Inc., a Missouri corporation ("Interim"), are hereby merged and that Mayflower is the surviving entity.

2. An Agreement and Plan of Merger was authorized and approved by each of Mayflower and Interim in accordance with R.S. Mo. § 347.720.

3. The effective date of the merger shall be the date of the filing of these Articles of Merger with the Missouri Secretary of State.

4. The registered office and the registered agent of Mayflower shall continue to be the registered office and registered agent of the surviving entity.

5. The Articles of Organization of Mayflower shall continue as the Articles of Organization of the surviving entity, provided, however, that Section 1 thereof is hereby amended to read in its entirety as follows:
