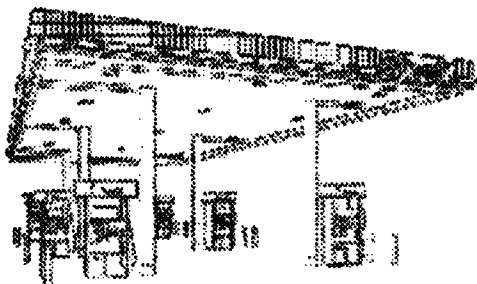
ASSIGNMENT
