ASSIGNMENT AGREEMENT

THIS AGREEMENT is made as of the 6th day of May, 2004 (the "Effective Date").

AMONG:

CAPITAL COMMUNICATIONS CDPQ INC. (the "Assignor"), a company incorporated under the laws of the Province of Quebec, having its head office at 1000 Place Jean-Paul Riopelle, Montreal, Quebec; and

AND:

MOSAIC DCPI HOLDINGS LLC (the "Assignee"), a Delaware limited liability company, having its head office at 9200 Sunset Boulevard, Los Angeles, California 90064

WHEREAS dick clark productions, inc., a Delaware corporation (the "Borrower"), Capital Communications CDPQ Inc. and Andell Holdings LLC, Charles Rosner Bronfman Family Trust and The Henry Winterstern Family Trust, as lenders (the "Lenders") are parties to a Credit Agreement dated July 25, 2002 (the "Credit Agreement") pursuant to which a term credit facility in the aggregate principal amount of US\$6,500,000 (the "Term Credit Facility") was made to the Borrower by the Lenders.

WHEREAS the Assignor wishes to sell, assign and transfer to the Assignee, according to Section 17.4 of the Credit Agreement all of its rights, claims and debts resulting or that may result in favour of the Assignor under the Term Credit Facility, the whole under the terms and subject to the conditions of the present Agreement and that certain purchase agreement dated as of the date hereof (the "Purchase Agreement") by and between Assignor and Assignee.

**NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:**

**1. INTERPRETATION**

**1.1 Definitions**

The capitalized terms used in this Agreement and not expressly defined herein have the same meanings herein as are ascribed to such terms in the Credit Agreement.

**1.2 Headings**

The division of this Agreement into Articles, Sections, paragraphs, sub-paragraphs and clauses and the insertion of headings are for the convenience of reference only and shall not affect the construction or interpretation of this Agreement.

**1.3 General Interpretation**

Words importing the singular number only shall include the plural and vice versa and words importing the masculine gender shall include the feminine and neuter genders and vice versa.

**1.4 References to this Agreement**

The terms "this Agreement", "hereof", "hereunder" and similar expressions used herein refer to this Agreement and not to any particular Article, Section, paragraph, sub-paragraph, clause or other portion hereof and include any agreement or instrument supplemental or ancillary hereto.

**1.5 Governing Law**

This Agreement shall be governed by and construed in accordance with the Laws of the State of New York.

**1.6 Schedules**

The schedules annexed hereto shall form an integral part of this Agreement.

**2. [RESERVED]****3. EXAMINATION OF DOCUMENTS**

The Assignee hereby acknowledges having received and examined the Credit Agreement and the other Loan Documents and confirms being satisfied therewith.

**4. DECLARATIONS**

4.1.1 The Assignor declares that the Borrower's indebtedness to the Assignor in respect of the Assignor's Term Loan Indebtedness, as of May 4, 2004, is US\$1,659,505, as evidenced by the Original Promissory Note.

4.1.2 The Assignor hereby declares that, to its knowledge, no Event of Default has occurred under the Credit Agreement.

4.1.3 The Assignor represents and warrants that (i) it is the legal and beneficial owner of the interest being assigned by it hereunder and that such interest is free and clear of any priority, charge, lien, hypothec, security interest or other adverse claim; (ii) it is duly organized and existing and it has the full power and authority to take, and has taken, all action necessary to execute and deliver this Agreement and any other documents required or permitted to be executed or delivered by it in connection with this Agreement and to fulfill its obligations hereunder, (iii) no notices to, or consents, authorizations or approvals of, any person are required (other than any already given, obtained or contemplated in the Purchase Agreement) for its due execution, delivery and performance of this Agreement, and apart from any agreements or undertaking of filings required by the Credit Agreement or contemplated in the Purchase Agreement,

no further action by, or notice to, or filing with, any person is required of it for such execution, delivery or performance; and (iv) this Agreement has been duly executed and delivered by it and constitutes the legal, valid and binding obligations of the Assignor, enforceable against the Assignor in accordance with the terms hereof, except subject, as to enforcement, to bankruptcy, insolvency, moratorium, reorganization and other laws of general application relating to or affecting creditors' rights and to general equitable principles.

## 5. SALE, ASSIGNMENT, TRANSFER AND NOVATION

5.1.1 The Assignor hereby sells, assigns and transfers to the Assignee hereto present and accepting all of its rights, interests (including all security interests and, in particular, including the security interest granted by the Borrower in the trademarks set forth on Schedule A hereto, which was recorded in the U.S. Patent and Trademark Office on August 13, 2002 at reel 2258/0268, the security interest granted by the Borrower in the copyrights set forth on Schedule B hereto, which was recorded in the U.S. Copyright Office on August 14, 2002 at vol 3487/page 0076, and the security interest granted by certain subsidiaries of the Borrower in the copyrights set forth on Schedule C hereto which was recorded in the U.S. Copyright Office on August 14, 2002 at vol 3487/page 0754), claims and debts resulting or that may result in favor of the Assignor under its Term Loan Indebtedness and, by way of novation, the Assignee is substituted to the Assignor under such Term Loan Indebtedness.

5.1.2 The sale, assignment, transfer and novation referred to in Section 5.1.1 are made in consideration of a sale price contemplated in the Purchase Agreement to be paid by the Assignee to the Assignor on the Effective Date.

5.1.3 The Assignee is for all purposes considered to be a party to the Credit Agreement as if it were an original party thereto as Lender.

5.1.4 The obligations and undertakings of the Borrower towards the Assignee, as a Lender, are set forth in the Credit Agreement.

5.1.5 Except as set forth in Article 4 herein and in Purchase Agreement, the sale, assignment, transfer and novation contained herein are made by the Assignor without any warranty whatsoever and at the own risk of the Assignee; without limiting the generality of the foregoing, the Assignee recognizes that the sale, assignment, transfer and novation made to it by the Assignor hereunder have been made without any representation or warranty whatsoever except the declarations made in Article 4 herein and in the Purchase Agreement from the Assignor; furthermore, the Assignee recognizes that it has conducted an analysis of the financial condition and affairs of the Borrower before executing this Agreement; consequently, the Assignee waives any claims or recourses against the Assignor except as set forth in the Purchase Agreement.

5.1.6 The Assignor is hereby released of its obligations towards the Borrower with respect to the portion of its Term Loan Indebtedness being assigned hereunder and the Borrower is hereby released of its obligations towards the Assignor with respect to the portion of its Term Loan Indebtedness being assigned hereunder.

**5.1.7 [RESERVED]**

5.1.8 The parties hereto acknowledge and agree that the sale, assignment, transfer and novation contained herein cover and are subject to the following agreements, contracts, deeds, documents, and instruments and all the rights, obligations, titles and interests of the Assignor in and to all said agreements, contracts, deeds, documents, and instruments, and all other rights, obligations, recourses and benefits created and intended to be created in favour of the Assignor, whether directly or beneficially, under the said agreements, contracts, deeds, documents, and instruments, and each one thereof, namely:

- (a) the Credit Agreement;
- (b) the Security Documents;
- (c) the Subordination Agreements;
- (d) any and all other documents, writings and certificates contemplated by the provisions of, and accessory to, the above-mentioned agreements and documents; and
- (e) any opinions or certificates of advocates, barristers, solicitors, notaries, attorneys, consultants, engineers, and other professionals issued pursuant to or otherwise contemplated by the provisions of the above-mentioned agreements and documents and a portion equal to all of the right, title and interest of the Assignor in and to all said opinions and certificates.

5.1.9 The Assignor hereby authorizes the filing of any financing statements or amendments relating to the financing statements currently filed in connection with the documents referenced in Section 5.1.8, including, without limitation, any financing statements "in lieu" of continuation statements, terminations, continuations, assignments or other amendments.

5.1.10 This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original and all of which taken together shall be deemed to constitute one and the same instrument, and it shall not be necessary in making proof of this Agreement to produce or account for more than one such counterpart.




