July ASSIGNMENT AGREEMENT ("Agreement"), dated as of this 28th day of July, 2003 by and between Wheaton USA Inc., d/b/a Alcan Packaging, a New Jersey corporation ("WHEATON") in favor of Scientific Holdings Corporation., a Delaware corporation, with place of business at 2751 Centerville Road, Suite 358, Wilmington DE 19808 ("VWR").

RECITALS:

WHEREAS, WHEATON desires to assign all of its right, title and interest in and to that certain trademark, REDI-CAP to VWR, and

WHEREAS, VWR desires to acquire all of WHEATON'S right title and interest in the Trademark:


AGREEMENT:

NOW, THEREFORE, in consideration of one dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:


1. Assignment. WHEATON hereby assigns, transfers, and conveys unto VWR, its successors, legal representatives and assignees, all of its right, title and interest in and to the registered Trademark on the Principal Register: REDI-CAP, Registration No. 2,588,517 Registered July 2, 2002 (the "Trademark"), including all registrations and applications thereof, as well as the goodwill symbolized by the Trademark, and the right to sue for, collect and retain all damages and profits and all other remedies for past infringements thereof.
2. VWR hereby assumes and agrees to become responsible for all liabilities with respect to the use, on or after the date of assignment, and maintenance of said Trademark.
3. This Agreement shall be governed by and construed in accordance with the domestic laws of the State of New Jersey without giving effect to any choice or conflict of law provision or rule (whether of the State of New Jersey or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of New Jersey.
