

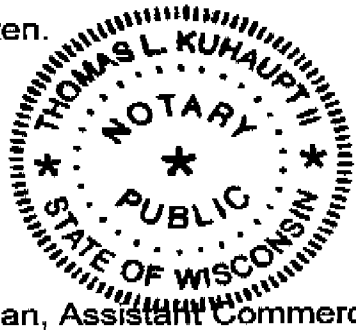
**W I T N E S S E I H:**
