REPORT OF SALE

Comes now David E. Grochocinski, Trustee in Bankruptcy for the Estate of Intelledge Corp. and in reporting to the Court on the results of the sale of assets of the aforesaid Debtor states as follows:

1.) On 2/24/99, this Court entered an order authorizing the Trustee to sell certain personal property (desks, business equipment and furniture) to IPMS, Inc. of Sterling, Virginia for the sum of \$7,500.00. Said sum has been paid and a bill of sale issued to the purchaser (copy attached).

2.) The same order authorized the Trustee to arrange for and conduct an auction sale on a date and time as selected by the Trustee and his auctioneer, Auction Services, Inc. for the Intellectual Property and related personal property of the Debtor.

3.) The order provided for a minimum opening bid of \$25,000.00 or if no such bid was received then the Trustee was authorized to sell the Intellectual Property and related personal property to IPMS, Inc. for \$20,000.00.


4.) Prior to this sale, IPMS deposited the sum of \$20,000.00 with Auction Services, Inc. which in turn deposited the same with the Trustee.

5.) On 5/26/99 the Trustee sent notice of an auction sale to all creditors and others entitled to

notice. Said notice set the sale for 6/22/99 at the offices of the Trustee at 2 p.m. Central Daylight Time (copy of the notice being attached).

6.) At the sale no person exceeded the bid of IPMS and the Intellectual Property and related personal property was sold in "as is and where is" condition to IPMS for \$20,000.00.
