BETWEEN:-

- (1) TJ SMITH & NEPHEW LIMITED (Company number 03994) whose registered office is PO Box 81, 101, Hessle Road, Kingston upon Hull, HU3 2BN (the "Assignor"); and
- (2) SMITH & NEPHEW HOMECRAFT LIMITED (Company number 137877) whose registered office is Shelley Close, Lowmoor Business Park, Kirkby in Ashfield, Nottinghamshire NG17 7ET (the "Assignee").

WHEREAS:-

- (A) The Assignor is the registered proprietor of the registered trade marks and of the benefit of the applications for registrations of the trade marks particulars of which are set out in the Schedule attached hereto (together the "Trade Marks").
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out herein.

IT IS AGREED as follows:-

- 1. The Assignor shall at its own expense do and execute or procure that there shall be done and executed all such documents deeds matters acts and things as the Assignee may at any time require properly to vest the Trade Marks or any one or more of them in the Assignee and for conferring on the Assignee rights of action in relation to any infringement by third parties of the Trade Marks which may have occurred.
- 3. The Assignee shall be solely responsible for the conduct and cost of any and all steps necessary to register the Assignee as the registered proprietor of the Trade Marks and for the avoidance of doubt, shall prepare all documents required by any Trade Mark Registry in the territories in which such marks are registered or applied for, and be liable for all costs of recordal and conduct (and bear the costs of) all correspondence with such registries in relation to such assignments.
- 4. This assignment (and any dispute, controversy, proceedings or claim of whatever nature arising out of or in any way relating to this assignment or its formation) shall be governed by and construed in accordance with English law.
- 5. Each of the parties to this assignment irrevocably agrees that the courts of England shall have exclusive jurisdiction to hear and decide any suit, action or proceedings and/or to settle any disputes which may arise out of or in connection with this assignment and, for these purposes, each party irrevocably submits to the exclusive jurisdiction of the courts of England.
