ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE ONE

The name of the Corporation is Champion Chemicals, Inc.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on May 23, 1990.

The amendment changes Article 1 of the Articles of Incorporation so as to change the name of the Corporation from Champion Chemicals, Inc. to Champion Technologies, Inc., so that Article 1 as amended now reads as follows:

"Article 1

The name of the Corporation shall be Champion Technologies, Inc."

ARTICLE THREE

The number of shares of the Corporation outstanding at the time of such adoption was 2000, and the number of shares entitled to vote thereon was 1900. All of such shares were Common Stock.

ARTICLE FOUR

The number of shares voted for such amendment was 1900, and the number of shares voted against such amendment was -0-.

ARTICLE FIVE

No exchange, reclassification or cancellation of issued shares is provided for in the amendment.

ARTICLE SIX

No change in the stated capital of the Corporation is effected by reason of the amendment.
