IN WITNESS WHEREOF, Assignor has caused this Release to be duly executed by its officer thereunto duly authorized as of the Effective Date.

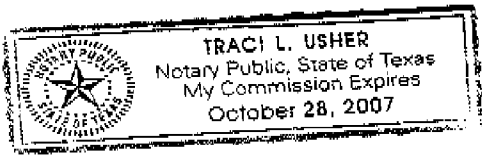


