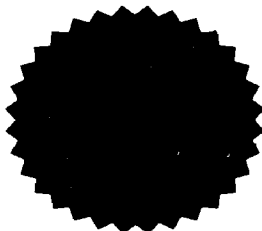

RESOLVED, that North American Biologicals, Inc. merge, and it hereby does merge into itself, NABI, Inc. and assumes all its obligations;

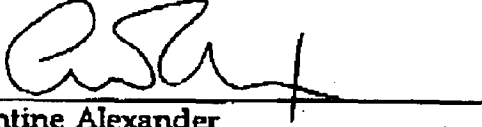
FURTHER RESOLVED, that the merger shall be effective upon the date of filing with the Secretary of State of Delaware; and
