ARTICLES OF AMENDMENT
TO ARTICLE OF INCORPORATION OF
MARSHALLTOWN TROWEL COMPANY

TO THE SECRETARY OF STATE OF IOWA OF THE STATE OF IOWA:

Pursuant to Section 490.1001 of the Iowa Business Corporation Act, the undersigned Corporation adopts the following amendment to the Corporation's Articles of Incorporation:

1. The name of the Corporation is Marshalltown Trowel Company.
2. The Corporation elects to change its name by amending Article I of its Articles of Incorporation by deleting therefrom the following:

"ARTICLE I

The name of this Corporation shall be 'MARSHALLTOWN TROWEL COMPANY.'

and substitute in lieu thereof the following:

"ARTICLE I

The name of this Corporation shall be 'Marshalltown Company.'

3. This amendment shall become effective upon filing with the Iowa Secretary of State.

4. The amendment was approved by the shareholders of the Company. The designation, number of outstanding shares, and number of votes entitled to be cast by each voting group entitled to vote separately on the amendment and the number of votes of each voting group indisputably represented at the meeting, is as follows:

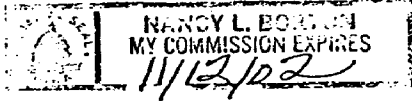
