
CONFIRMATION OF TRADEMARK ASSIGNMENT



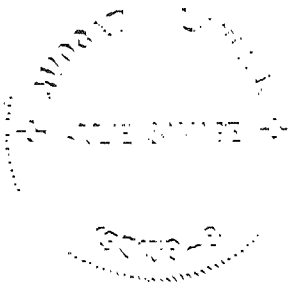
