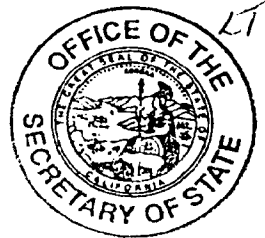
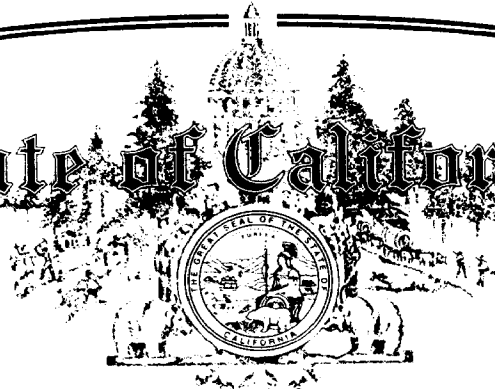

2. Article FIRST of the Articles of Incorporation of this corporation is hereby amended to read in full as follows:

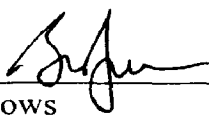
FIRST: The name of this Corporation is BURROWS GOLF, INC.

3 The foregoing amendment of the articles of incorporation has been duly approved by the Board of Directors of this corporation.

4. The foregoing amendment of articles of incorporation has been duly approved by the required vote of shareholders of the corporation in accordance with Sections 902 and 903 of the Corporations Code. The total number of outstanding shares entitled to vote with respect to the foregoing amendment was 45,455,000 shares of Common Stock. The number of shares voting in favor of the foregoing amendment was 45,050,000 shares of Common Stock, representing ninety nine percent of the issued and outstanding shares of this corporation.
