1. I, ~~Patricia A. Wilson~~, am the ~~General Counsel~~ of NDCHHealth Corporation f/k/a National Data Intellectual Property Corp. and f/k/a National Data Corporation (consolidated herein as "NDCHHealth"). I certify that I am of legal age, and that I am authorized to offer this Declaration on behalf of NDCHHealth.
2. NDCHHealth is the owner of certain trademark applications and registrations as listed in Appendix A attached hereto.
3. National Data Corporation (a Delaware corporation), assigned all right, title and interest in and to certain trademarks to National Data Intellectual Property Corp. (a Delaware corporation). Trademark Assignment documents relating to the transfer of rights to Assignee, National Data Intellectual Property Corp., inadvertently refer to National Data Corporation, the Assignor, as a "Georgia" corporation, instead of Delaware. Similarly, maintenance documents filed with the Patent and Trademark Office inadvertently list National Data Corporation as a "Georgia" corporation, instead of Delaware. These mistakes were inadvertent and the Trademark Assignment and maintenance documents were executed in good faith by the correct parties. National Data Corporation was in fact, at all pertinent times, a "Delaware" corporation. National Data Intellectual Property Corporation was, in fact, at all pertinent times, a "Delaware" corporation.
4. Under a plan of reorganization, National Data Intellectual Property Corp. (a Delaware corporation) assigned all right, title and interest in and to certain trademarks back to National Data Corporation (a Delaware corporation). The transfer of rights was memorialized in a Trademark Assignment document in which, again, National Data Corporation, the Assignee, was mistakenly referred to as a "Georgia"

corporation" instead of a Delaware corporation. Similarly, maintenance documents filed with the Patent and Trademark Office inadvertently list National Data Corporation as a "Georgia" corporation. The mistake was inadvertent and the Trademark Assignment Document and maintenance documents were executed in good faith by the correct parties. National Data Corporation was in fact, at all pertinent times, a "Delaware" corporation. National Data Intellectual Property Corporation was in fact, at all pertinent times, a "Delaware" corporation.

5. In connection with a divestiture, National Data Corporation (a Delaware corporation) underwent a name change to NDCHealth Corporation (a Delaware corporation). The company's change of name was recorded in the records of the Assignment Branch of the Patent and Trademark Office. In these filings, owner, NDCHealth Corporation (a Delaware corporation) was mistakenly referred to as a "Georgia" corporation instead of a "Delaware" corporation. Similarly, trademark applications and maintenance documents filed with the Patent and Trademark Office inadvertently list NDCHealth Corporation as a "Georgia" corporation instead of Delaware. The mistake was inadvertent and the Trademark Recordation Coversheets, maintenance documents, and trademark applications were executed in good faith by the company. NDCHealth Corporation was in fact, at all pertinent times, a "Delaware" corporation.
6. NDCHealth Corporation (a Delaware corporation), assigned all right, title and interest in and to certain trademarks to NDCHealth Intellectual Property Corp. (a Delaware corporation). The assignment was submitted for recordation with the Assignment Branch of the Patent and Trademark Office. NDCHealth Corporation and NDCHealth Intellectual Property Corp. are, and have always been, "Delaware" corporations.
7. Now, having completed the business reorganization of NDCHealth, corporate representatives of the original assigning entities named in the

trademark assignments, applications, and maintenance and renewal documents are no longer available to execute new or corrective assignment documents or declarations.

The undersigned, being hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements and the like may jeopardize the validity of this registration, declares that all statements made of his/her own knowledge are true and that all statements made on information and belief are believed to be true.


