RELEASE OF SECURITY INTEREST
IN TRADEMARKS

WHEREAS, WOODLAND BLINDS. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby releases, retransfers and reassigns to Grantor, without representation or warranty of any kind, express or implied, all of Agent's right, title and interest as against the Grantor in and to the Marks and the goodwill associated therewith.

Agent's execution or delivery of this instrument does not constitute (a) a waiver or release of any indebtedness or other obligation on the part of Grantor, or any other grantor, under any document, instrument or agreement secured by, or described in, the Security Agreement, (b) a waiver of any (i) default or event of default, or (ii) any right, power, privilege or remedy on the part of Grantor, or any other grantor, under any such document, instrument or agreement, or (c) a release, retransfer or reassignment of Agent's right title and interest, if any, as against anyone other than the Grantor (including any other grantor) in and to the Marks and the goodwill associated therewith.
