RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is dated as of August 8, 2002 by LaSalle Business Credit, Inc., individually and as Agent for the benefit of the Lenders ("LaSalle").

WHEREAS, LaSalle and Specialty Filaments, Inc., formerly known as Polymers, Inc., a Delaware corporation, and successor by merger to Hahl Filaments, Inc., a South Carolina corporation ("Borrower"), entered into that certain Amended and Restated Trademark Security Agreement (the "Trademark Security Agreement"), dated as of September 23, 1998;

WHEREAS, the Trademark Security Agreement granted LaSalle a security interest in, among other things, certain trademarks, tradenames, trademark registrations, service marks, trade styles, terms, designs and trademark applications ("Trademarks"), including, without limitation, the Trademarks listed on Schedule A attached hereto as security for certain obligations of Borrower to LaSalle (the "Obligations");

WHEREAS, LaSalle recorded the Trademark Security Agreement on October 8, 1998 at Reel 1797, Frame 0812 in the United States Patent and Trademark Office; and

WHEREAS, Borrower has satisfied all of the Obligations and has requested that LaSalle release its security interests in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LaSalle hereby agrees as follows:

LaSalle hereby fully releases and terminates its security interests in and liens on:

(a) all of Borrower's now existing or hereafter acquired right, title and interest in and to: all Trademarks which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Trademarks have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;


(b) the goodwill of Borrower's business connected with or symbolized by Trademarks; and

(c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Borrower against third parties for infringement of the Trademarks or of any license with respect thereto.

LaSalle further agrees, at the sole cost and expense of Borrower, to perform all acts reasonably necessary to effect the release and termination of its security interest and liens, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.
