RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is made as of the 1st day of March, 2004 by Owens Corning, a Delaware corporation and IPM, Inc., a Delaware corporation, both with it's principal place of business at One Owens Corning Parkway, Toledo, Ohio 43659 (collectively the "Secured Party").

WHEREAS, Bulk Molding Compounds, Inc., an Illinois corporation, with its principal place of business at 1600 Powis Court, West Chicago, Illinois 60185 ("BMC"), owns the trademarks, trademark applications and trademark registrations listed on Exhibit A attached hereto ("Listed Trademarks"), which trademarks are registered in the United States Patent and Trademark Office (the "Office"); and

WHEREAS, BMC, had entered into an agreement with Cytec Technology Corp., a Delaware corporation, to license the trademarks, trademark applications and trademark registrations listed on Exhibit B attached hereto ("Licensed Trademarks"), which trademarks are registered in the United States Patent and Trademark Office (the "Office"); and

WHEREAS, BMC granted to the Secured Party a security interest in (i) all of its trademarks, trademark registrations and trademark applications, including but not limited to the Listed Trademarks, and the registrations thereof, (ii) associated business goodwill therein, and (iii) its interest in the Licensed Trademarks, all as described in that certain security agreement dated November 23, 1998 executed by BMC and previously filed for record in the Office on February 8, 1999 at Trademark Reel and Frame No. 1853/0834 (the "Security Agreement"); and

WHEREAS, the Secured Party delivered a partial release to BMC dated January 11, 2000 and previously filed for record in the Office on January 27, 2000 at Trademark Reel and Frame Nos. 2029/0990 and 2030/0053; and

WHEREAS, the Secured Party has released its remaining security interest in all of the trademarks, trademark applications and trademark registrations, including the Listed Trademarks, and the registrations thereof and the associated goodwill therein and the Licensed Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases its security interest in all of the trademarks, trademark applications and trademark registrations, including the Listed Trademarks, and the registrations thereof and the associated business goodwill therein, and the Licensed Trademarks, as granted in the Security Agreement.
