NOW, THEREFORE, to all whom it may concern, be it known that for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and in accordance with the Bill of Sale, Assignment and Agreement dated October 24, 2003,

between the Assignor and the Assignee, the Assignor has sold, assigned, transferred, conveyed and set over and does hereby sell, assign, transfer, convey and set over to the Assignee, all rights, title and interest in and to the aforementioned trademark together with the goodwill of the business appertaining to and symbolized by the trademark to be held and enjoyed by the Assignee, for its own use and enjoyment and the use and enjoyment of its successors, assignees or other legal representative, as fully and entirely as the same would have been held and enjoyed by the Assignor, if this assignment and sale had not been made, including without limitation, the right to maintain and renew the registration of the trademarks, the right to recover for past infringement and to make application or institute suit therefore.

The Assignor hereby authorizes the Assignee to apply for and obtain the recordation of this Assignment. The Assignor agrees that it shall, without further consideration, promptly and duly cause to be performed such lawful acts and execution of any other documents as the Assignee may reasonably request in order for the Assignee to obtain the full benefit of this Assignment and to permit the Assignee to be duly recorded in each office, bureau and tribunal in the appropriate jurisdiction as the registered owner or proprietor of each of the rights hereby assigned. Such instruments and documents shall include, without limitation, affidavits, including affidavits of use, and other documents of filing in such jurisdictions as the Assignee may from time to time reasonably request.

The Assignor hereby represents and warrants that there are no rights and interests outstanding inconsistent with the rights and interest granted herein and that

the Assignor will not execute any instrument or grant or transfer any rights or interests inconsistent therewith.

The Assignment is effective the date and year above first written, regardless of the date of actual signature set forth below.

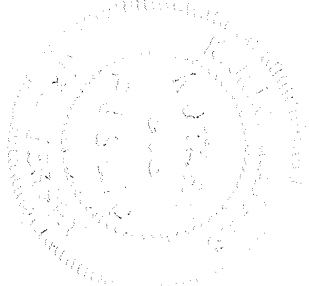
