## RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is executed as of the 18<sup>th</sup> day of May, 2004, by BANK OF AMERICA, N.A., a national banking association in its capacity as administrative agent (the "Administrative Agent") for itself and each financial institution party to the Credit Agreement (hereafter defined) (the "Lenders").

WHEREAS, Da-Lite Screen Company, Inc., an Indiana corporation (the "Borrower"), the Administrative Agent and the Lenders entered into that certain Credit Agreement dated as of August 15, 2002 (as amended through the date hereof, the "Credit Agreement").

WHEREAS, in connection with the Credit Agreement, the Borrower, Visual Structures, Inc., a California corporation (with the Borrower, collectively referred to herein as the "Grantor") and the Administrative Agent entered into that certain Security Agreement, dated as of August 15, 2002 (the "Security Agreement").

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Administrative Agent was granted a security interest in all of the Grantor's interests in the collateral more specifically described on Exhibit A attached hereto (the "Collateral").

WHEREAS, such Security Agreement was filed with the United States Patent and Trademark Office on September 3, 2002, and recorded against the trademark Collateral at Reel/Frame 002577/0049 and against the patent Collateral at Reel/Frame 013247/0286.

WHEREAS, the Administrative Agent has received consideration for a full and complete release of the security interest in and liens in the Collateral, and now wishes to release such security interest and liens in the Collateral.

NOW THEREFORE, the Administrative Agent represents and agrees as follows:

1. The Administrative Agent hereby releases, cancels and terminates all of its right, title and interest in and to the Collateral, including its security interest in and liens on the Collateral and all other rights with respect to the Collateral, and conveys and assigns any and all right, title and interest that it may have in and to the Collateral to the Grantor.
2. The Administrative Agent represents that it has not exercised any of the rights with respect to the Collateral available to it under the Security Agreement. The Administrative Agent represents and warrants that it has not sold, licensed, conveyed or otherwise alienated any rights in and to the Collateral, and that it has not practiced or sublicensed any of the Collateral.
3. Without limiting the generality of the foregoing, this Release is intended to and shall forever terminate the irrevocable rights in the Collateral conveyed to the Administrative Agent and reconvey such rights to the Grantor.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed by its officer thereunto duly authorized as of the date hereof.

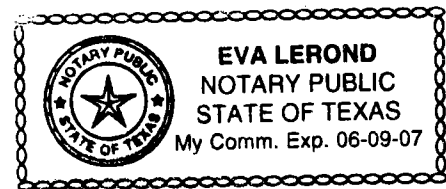
