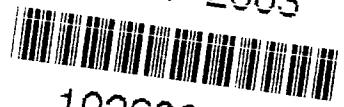

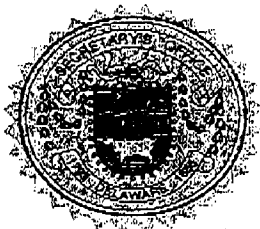

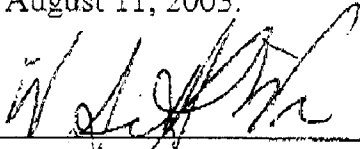
1. He is the duly elected and acting President of Redlite Acquisition Corporation, a Delaware corporation.
