


Assignment of Trademark

Assignor warrants that there are no licenses, encumbrances, or other agreements, either written, oral or implied, relating to the Trademarks, and that it has good and valid title to the marks to assign to Assignee.

Assignor further warrants that, upon the request of Assignee, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this agreement, as well as to provide such other material, information and/or assistance as Assignee may consider necessary, and this agreement shall be binding upon the

parties, their successors and/or assigns, and all others acting by, through, with or under their direction and all those in privity therewith.
