



Addendum to Trademark Assignment

This Addendum of Trademark Assignment ("Addendum") is made as of March 5, 2003, by and between Webster Bank, a federally chartered savings bank with an office at 145 Bank Street, Waterbury, Connecticut 06702 ("Assignor"), and Crystal Rock Spring Water Company, a Connecticut corporation, having a place of business at 1050 Buckingham Street, Watertown, CT 06795 ("Assignee").

WHEREAS, Assignor and Assignee have entered into a Trademark Assignment dated March 5, 2003 ("Assignment Agreement"), and the Assignment Agreement has been recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 002686/0751, against the Trademarks listed in the schedule hereto; and

WHEREAS, Assignor and Assignee wish to clarify the Assignment Agreement as more specifically described herein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree to as follows:

Assignor and Assignee agree that, during the period commencing with assignment of the Trademarks from Assignee to Assignor as additional security for certain obligations under the Collateral Assignments of Trademarks dated October 5, 2000 and as of November 1, 2001 ("Collateral Assignment"), and ending with assignment of the Trademarks from Assignor to Assignee as of March 5, 2003 under the Assignment Agreement, Assignee continued to use the Trademarks in its business as if it had not made the Collateral Assignment, namely: the Assignee maintained the same or a higher standard of quality of the goods and services distributed or sold by Assignee in connection with the Trademarks during such period as was maintained prior to such period, Assignor had the right to inspect and control the quality of such goods and services so as to assure that such standards were met by Assignee during such period, and all such use of the Trademarks by Assignee during such period inured to the benefit of Assignor as the then-owner of the Trademarks.

Capitalized terms used herein shall have the meaning given in the Assignment Agreement. The Assignment Agreement shall be and remain effective as of March 5, 2003.
