ASSIGNOR further assigns to ASSIGNEE the right to claim priority or other rights deriving from any trademark application by virtue of international convention, treaty, or otherwise. The TRADEMARKS and all trademarks and trademark applications assigned hereby to be held and enjoyed by ASSIGNEE for its use and benefit and by its successors and assigns for their use and benefit as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had this agreement, transfer and sale not been made.
