TRADEMARK ASSIGNMENT

WHEREAS, Horseshoe Bowl, L.P. ("Horseshoe"), a Texas limited partnership having a place of business at 200 East 6th Street, Floor 2, Austin, Texas 78701, has adopted and is presently using certain trademarks, including the trademarks which are the subject of federal or state registrations or pending applications listed on Schedule A attached hereto (the "Marks");

WHEREAS, Salton, Inc. ("Salton"), a Delaware corporation having a place of business at 1955 W. Field Court, Lake Forest, Illinois 60045, is desirous of acquiring said Marks, and the registrations and applications therefor, and the goodwill associated therewith;

WHEREAS, Salton is desirous of acquiring the Marks that are the subject of pending federal applications as part of the entire business or portion thereof to which those Marks pertain, as required by 15 U.S.C. § 1060;

NOW, THEREFORE, in consideration of the payment of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Horseshoe hereby assign to Salton, all right, title and interest in, to and under said Marks and the registrations and applications therefor, together with the goodwill of the business connected with the use of and symbolized by the Marks; and together with the entire business or portion thereof to which the Marks pertain; and together with all causes of action for the infringement of such Marks. In the event either Horseshoe or Salton terminate that certain Asset Purchase Agreement, dated as of March 19, 2004, by and between Horseshoe and Salton (the "APA") in accordance with Section 7 therein, this Trademark Assignment shall become null and void and of no force and effect; and all right, title and interest in and to the Marks assigned hereunder shall revert back to Horseshoe and thereafter, Salton agrees to take all action necessary to comply with its obligations as outlined in Section 7 of the APA.

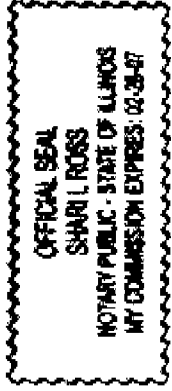
