# TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is made effective as of October 14, 2003, between Tenet Healthcare Corporation, a Nevada corporation, ("Assignor"), and Tenet Florida, Inc., a Delaware corporation ("Assignee"):

## RECITALS

WHEREAS, Assignor whose address is 3820 State Street, Santa Barbara, California 93105, has adopted, used and is using trademarks called "Tenet South Florida HealthSystem" which registration numbers are: 2,049,809, dated April 1, 1997; 1,967,096, dated April 9, 1996; 1,965,858, dated April 2, 1996; 1,979,675, dated June 11, 1996; 1,967,097 dated 4-9-96; 2,062,051, dated May 13, 1997; 1,965,859, dated April 2, 1996; and 1,995,141, dated August 20, 1996 (collectively, the "Trademarks"); and

WHEREAS, Assignee whose address is 500 West Cypress Creek Road, Suite 700, Fort Lauderdale, FL 33309, is desirous of acquiring said registered Trademarks.

NOW, THEREFORE, in consideration of the foregoing Recitals and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor and Assignee agree as follows:

## AGREEMENT

1. Assignor represents and warrants to Assignee that: (a) it has the corporate power and authority to enter into this Agreement; (b) it has full right, title and interest in the Trademarks and the goodwill associated with the Trademarks; (c) no claim of infringement of any trademark or other intellectual property right, privacy or similar right has been made or is pending against Assignor; and (d) neither the Trademarks nor any proprietary rights associated therewith infringe any proprietary rights of any third parties.

2. Assignor grants to Assignee all of its right, title, and interest and the goodwill of the Trademarks and the business symbolized thereby.

3. Assignee accepts said Trademarks from Assignor.
