TRADEMARK ASSIGNMENT

WITNESSETH:

WHEREAS, Assignor is the record owner of the trademark and the related United States application listed in Exhibit A (the "Mark"); and

WHEREAS, Assignor desires to assign to Assignee all right, title and interest in and to the Mark, together with the goodwill of the business, and all common law rights, associated with the Mark; and

WHEREAS, Assignee desires to acquire the Mark, together with the goodwill of the business, and all common law rights, associated with the Mark; and

WHEREAS, Assignor and Assignee desire to confirm the assignment of the Mark to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby assigns, transfers and conveys to Assignee all right, title and interest in and to the Mark, together with (a) the goodwill of the business symbolized by the Mark, (b) any and all common law rights, title and interest associated with the Mark, and (c) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Mark.

Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such confirmatory assignments and other legal documents as Assignee, or its counsel, may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the legal and registered owner of the Mark and all of the rights hereby conveyed.
