**TERMINATION AND RELEASE OF SECURITY INTERESTS
IN CERTAIN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS ("Release"), dated as of May 28, 2004, by **FLEET NATIONAL BANK (f/k/a BANKBOSTON, N.A.)** a national banking association, as agent (the "Agent") for itself and the other lending institutions which is party to that certain Amended and Restated Loan Agreement dated as of May 10, 2002 (as amended and in effect from time to time, the "Loan Agreement"), among LogistiCare Solutions, LLC (the "Company"), Fleet National Bank and Brown Brothers Harriman & Co. as lenders (the "Lenders") and the Agent.

WHEREAS, pursuant to the terms of that certain Patent and Trademark Security Agreement between the Company and the Agent and recorded with the USPTO on or about September 16, 1999 (Reel Number 1958 and Frame Number 0789), each for the purpose of securing certain obligations of the Company to the Agent, on behalf of itself and the lenders party thereto, the Company granted to the Agent, for the benefit of the Lenders, a security interest in and lien on, and collaterally assigned to the Agent all of its trademarks, trademark registrations and associated goodwill, including, without limitation, the Trademarks identified on Schedule A attached hereto) (such Trademarks referred to herein as the "Named Trademarks"); and

WHEREAS, the Agent has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent and the Company hereby agree as follows:

1. **Release and Assignment.** The Agent hereby terminates and releases its security interest in and first priority lien on all of the Company's Named Trademarks, and the Agent hereby assigns and transfers to the Company, without recourse, all of the Agent's right, title and interest in and to each of the Named Trademarks and the related patent registrations and goodwill, effective as of the date set forth above.

2. **Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.

IN WITNESS WHEREOF, the Agent and the Company have executed this Release, to effect as of the date first set forth above.
