ASSIGNMENT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This ASSIGNMENT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS is effective as of July 31, 2003, and is made by Comdisco Ventures, Inc., a Delaware corporation and the successor in interest to Comdisco, Inc., with its principal place of business at 6111 North River Road, Rosemont, Illinois ("Comdisco"), in favor of Netcubator II, LLC, a Delaware limited liability company, with its principal place of business at 301 North Lake Avenue, Suite 910 Pasadena, CA 91101 ("Purchaser").


WHEREAS, Comdisco and Purchaser are parties to that certain Purchase and Sale Agreement dated as of July 31, 2003 (the "Agreement"), pursuant which Comdisco agreed to sell to Purchaser, and Purchaser has agreed to buy from Comdisco, the Purchased Assets (as defined in the Agreement), including, without limitation, Comdisco's security interest in certain patents and trademarks of Linuxcare, Inc., as evidenced by certain Collateral Grant of Security Interest in Patents and Trademarks, dated as of November 6, 2002 (the "Patent and Trademark Agreement"), executed by Linuxcare, Inc., in favor of Comdisco;

WHEREAS, pursuant to the Agreement, Comdisco has agreed to execute such instruments to assign, transfer, grant, convey Comdisco's right and interest under the Patent and Trademark Agreement to Purchaser;

NOW, THEREFORE, Comdisco, for and in exchange for the payment of the Cash Purchase Price set forth in the Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Purchaser, and Purchaser hereby accepts the transfer and assignment of, all of Comdisco's right, title and interest in, to, and under the Patent and Trademark Agreement.
