## MORTGAGE AND SECURITY INTEREST ASSIGNMENT

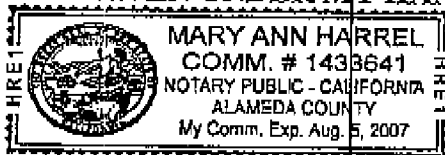

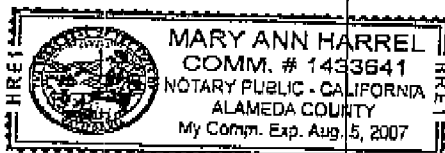

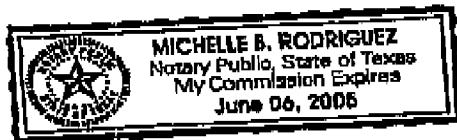
