ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment"), dated December 19, 2000 is by ONE-ON-ONE SPORTS, INC., a Delaware corporation, ONE-ON-ONE SPORTS RADIO STATIONS, INC., a Delaware corporation, ONE-ON-ONE SPORTS ON-SITE, INC., a Delaware corporation, and ONE-ON-ONE SPORTS NETWORK, INC., a Delaware corporation, and the LLC SUBSIDIARIES (as defined in the Purchase Agreement) (collectively, the "Assignors"), to VULCAN PRINT MEDIA, INC. (d.b.a. Sporting News), a Delaware corporation (the "Assignee").

RECITALS

A. The Assignors have adopted, used and are using the trademarks and domain names which are listed in Schedule 1 attached hereto and which are registered in the United States Patent and Trademark Office, with Networks Solutions, Inc. or another registrar of Internet domain names and/or used at common law (collectively, the "Trademarks") as indicated in Schedule 1.

B. In connection with that certain Asset Purchase Agreement dated November 27, 2000 by and among the Assignors and the Assignors' specified LLC Subsidiaries and Vulcan Radio Corporation and the Assignee, the Assignors' desire to assign the Trademarks to the Assignee, and the Assignee is desirous of acquiring all of the Assignors' rights, title and interest in and to the Trademarks, all federal, state and foreign registrations (if any) of or related to the Trademarks heretofore granted or applied for, including, without limitation, all renewals and extensions thereof, the right to file federal, state and foreign registrations, renewals and extensions of or related to the Trademarks, all actions, claims and causes of action related to the Trademarks, any and all damages, profits, penalties and other recoveries related to the foregoing and any and all common law rights of Assignor in and to the Trademarks in the United States, any state thereof and in foreign countries (collectively, the "Trademark Rights").

AGREEMENTS

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignors hereby irrevocably sell, transfer, and assign to the Assignee all of the Assignors' rights, titles and interests throughout the universe in perpetuity in and to the Trademarks and the Trademark Rights, together with the goodwill of the business symbolized by the Trademarks and the Trademark Rights.

The Assignors represent and warrant that each of them is free to enter into this Assignment and to assign the Trademarks and the Trademark Rights to the Assignee.

The Assignors further covenant and agree that, upon the request of the Assignee, the Assignors shall execute and deliver and cause to be executed and delivered to the Assignee any and all documents and instruments necessary to effect and complete the transfer to the Assignee of the Trademarks and the Trademark Rights, to make all rightful oaths, to testify on behalf of the Assignee and to do all other lawful acts necessary to carry out the intent of this Assignment, as well as to provide such other materials, information or assignments as the Assignee may


consider necessary, and this Assignment shall be binding on the Assignors, their successors and/or assigns and all others acting by, through, with or under its direction, and all those in privity therewith. If the Assignors fail to execute and deliver the documents, instruments and/or assignments described in the previous sentence, the Assignee is hereby authorized and appointed the Assignors' irrevocable Attorney-In-Fact of and for the Assignors to make, execute and deliver any and all such documents, instruments and/or assignments. 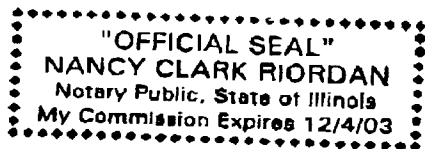



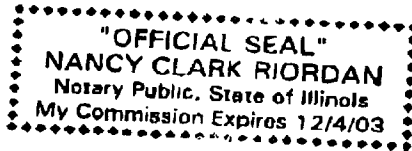
