### RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS is given as of this <sup>23<sup>rd</sup></sup> day of March, 2004 by Bank of America, N.A. a national banking association, located at 335 Madison Avenue, New York, New York 10017 (as successor in interest to BankAmerica Business Credit, Inc.) as Agent (as defined in the Security Agreement) on behalf of the Secured Creditors (as defined in the Security Agreement) ("Assignor"), in favor of Sweetheart Cup Company Inc., a Delaware corporation, located at 10100 Reisterstown Road, Owings Mills, Maryland 21117 ("Assignee").

**WHEREAS**, pursuant to the terms of a certain Security Agreement, dated as of August 30, 1993 (as amended, modified, supplemented or restated from time to time, the "Security Agreement") between Assignee and Bankers Trust Company, as collateral agent (in such capacity, the "Original Collateral Agent"), the Assignee granted to the Original Collateral Agent a security interest in, among other things, all right, title and interest of the Assignee in, to, and under, all of the Assignee's Trademarks and service marks, together with any reissues, extensions or renewals thereof, Trademark registrations, Trademark applications and Trademark licenses, whether presently existing or hereafter arising or acquired, and the goodwill of the business symbolized by the foregoing, all customer lists and other records of the Assignee relating to the distribution of products bearing the Trademarks, Trademark registrations, Trademark applications and Trademark licenses, and all proceeds thereof, including, without limitation, any claims by the Assignee against third parties for infringement of any of the foregoing to secure the payment of all amounts owing by the Assignee under or in connection with the Credit Agreement dated as of August 30, 1993 (as amended, supplemented, modified or restated from time to time, the "Credit Agreement") among Sweetheart Holdings Inc. ("Holdings"), the lenders party thereto (the "Original Lenders") and Bankers Trust Company, as agent (in such capacity, the "Original Agent").

**WHEREAS**, in connection with the aforesaid grant of a security interest, the Assignee executed a Collateral Assignment for Security in the U.S. Trademarks dated as of August 30, 1993 in favor of the Original Collateral Agent (the "Collateral Assignment"), which assignment was recorded with the United States Patent and Trademark Office on September 10, 1993 at Reel 1029 Frame 154;

**WHEREAS**, the Original Lenders, Original Agent and Original Collateral Agent have assigned, transferred and sold to BankAmerica Business Credit, Inc. all their respective right, title and interest in, to and under the Credit Agreement and the other documents and instruments executed in connection therewith (including, without limitation, the Security Agreement and the Collateral Assignment), all pursuant to a certain Assignment and Assumption Agreement (the "Assignment and Assumption Agreement"), dated as of the date hereof, among the Original Lenders, the Original Agent, the Original Collateral Agent, Bank of America Business Credit, Inc. the Assignee and Holdings;

**WHEREAS**, pursuant to the Assignment and Assumption Agreement, the Original Collateral Agent has resigned as collateral agent under, among other things, the Security Agreement and the Collateral Assignment and Bank America Business Credit, Inc., as agent (Bank America Business Credit Inc. in such capacity as agent, the "Successor Agent") has succeeded to the rights of the Original Collateral Agent thereunder; and

**WHEREAS**, in connection with such resignation, the Original Collateral Agent is assigning to the Successor Agent all of its right, title and interest into and under the Trademark Collateral (as hereinafter defined);

**WHEREAS**, in connection with the Assignment and Assumption Agreement, the Original Collateral Agent, the Successor Collateral Agent entered into an Assignment of Grant of Security Interest (Trademarks, Trademark Registrations, Trademark Applications and Trademark Licenses (the "Trademark Assignment of Grant") whereby the Trademark Assignment of Grant was recorded in the United States Patent and Trademark Office on November 7, 1997 at Reel 1652/Frame 0355.

**WHEREAS**, Assignee has satisfactorily performed all of its obligations under the Security Agreement and the Assignor desires to release its security interest in the Trademark Collateral, defined as follows:

- (i) each U.S. Trademark, service mark, Trademark registration and Trademark application of the Assignee, including, without limitation, each U.S. Trademark, service mark, Trademark registration and Trademark application referred to in Schedule A hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each U.S. Trademark, service mark, Trademark registration and Trademark application of the Borrower;
- (ii) each Trademark license of the Assignee, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark license;
- (iii) all customer lists and other records of the Assignee relating to the distribution of products bearing any of the Trademark, service marks, Trademark registrations, Trademark applications and Trademark licenses;
- (iv) the Security Agreement and any Collateral Assignment for Security in U.S. Trademarks executed in connection therewith (including, without limitation, the Collateral Assignment); and
- (v) all proceeds of any of the foregoing, including, without limitation, any claims by the Assignee against third parties for past, present or future infringement of any Trademark, service mark or Trademark registration or application including, without limitation, any Trademark, service mark or Trademark registration or application referred

to in Schedule A, and of any Trademark licensed under any Trademark license, including, without limitation, any Trademark license listed on Schedule A, or for injury to the goodwill associated with any Trademark, Trademark registration or Trademark licensed under any Trademark license;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in the Trademark Collateral to Assignee and, without representation, warranty or recourse of any kind, reverts the Assignee with full title to the Trademark Collateral.
