

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF TRILEGIANT CORPORATION

Pursuant to Sections 242 and 245 of the Delaware General Corporation Law	6

Trilegiant Corporation, a corporation organized and existing under the General Corporation Law of the State of Delaware (the "DGCL"), does hereby certify as follows:

- The name of the corporation is Trilegiant Corporation (the "Corporation"). The Corporation was originally incorporated under the name Trilegiant Corporation. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Dolaware on June 28, 2001 (the "Certificate of Incorporation").
