RELEASE OF TRADEMARK

THIS RELEASE OF TRADEMARK ("Release") is dated as of June 15, 2004 by LASALLE BANK NATIONAL ASSOCIATION ("LASALLE").

WHEREAS, LASALLE and Flambeau, Inc. (f/k/a Flambeau Products Corporation), an Ohio corporation ("Debtor"), entered into that certain Trademark Security Agreement (the "Existing Trademark Security Agreement"), dated as of February 22, 2002;

WHEREAS, the Trademark Security Agreement granted LASALLE a security interest in, among other things, certain trademarks, tradenames, trademark registrations, service marks, trade styles, terms, designs and trademark applications, as security for certain obligations of Debtor to LASALLE;

WHEREAS, LASALLE recorded the Existing Trademark Security Agreement on February 26, 2002 at Reel 2448, Frame 0945 in the United States Patent and Trademark Office; and

WHEREAS, Debtor has requested that LASALLE release its security interest in the trademark "Vu-Pack", Registration Number 1170245 ("Vu-Pack"), listed on Schedule I attached to the Existing Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LASALLE hereby agrees as follows:

LASALLE hereby fully releases and terminates its security interest in and lien on:


- (a) Vu-Pack and it is hereby deleted from Schedule I attached to the Existing Trademark Security Agreement;
- (b) the goodwill of Debtor's business connected with or symbolized by Vu-Pack; and
- (c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Debtor against third parties for infringement of Vu-Pack or of any license with respect thereto.

LASALLE agrees, at the sole cost and expense of Debtor, to perform all acts reasonably necessary to effect the release of its security interest and lien on Vu-Pack, including, but not limited to, the recording, filing and entering into any agreement, document, form or paper needed to accomplish such release and termination;

LASALLE and Debtor further agree that the Release of Trademark set forth hereof shall be limited precisely as written and except as expressly set forth in this Release, shall not be deemed to be a consent to any waiver or modification of any other term or condition of the Existing Flambeau Trademark Security Agreement or any other Financing Agreements.
