TRADEMARK ASSIGNMENT**

- (i) all goodwill associated with the business related to the trademark together with all rights to use, license and otherwise exploit the trademarks;
 - (ii) all income, royalties, damages, and payments hereafter due or payable to the Assignor with respect to the trademark, including without limitation unpaid damages and payments for past, present, and future infringements of the trademark;
 - (iii) all rights in and under the trademarks the fullest extent allowed by law as fully as the Assignor would have held the same in the absence of this assignment; and
 - (iv) all rights to sue and recover damages and payments for past, present, and future infringements or dilution of the trademark, including the right to fully and entirely replace the Assignor in all related matters.
2. This assignment is made in connection with the sale of the entire business to which the trademark relates. As of the date set forth in the heading of this Assignment, the Assignee has succeeded to all right, title, and standing of the Assignor to: (a) receive all rights and benefits pertaining to the trademark and related rights described above, and (b) commence, prosecute, defend and settle all claims and take all actions that the Assignee, in its sole discretion, may elect in relation to the trademark described above.
