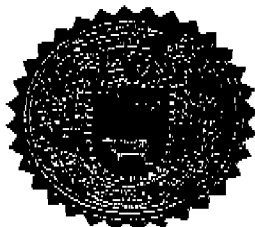

FIRST: The name and state of formation or organization of each of the constituent entities to the merger (the "Constituent Entities") is as follows:
