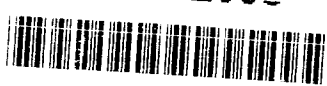

TRADEMARK SECURITY INTEREST AGREEMENT

THIS TRADEMARK SECURITY INTEREST AGREEMENT (the "Agreement") dated as of November 21, 2003 is made by and between CONTAINER GRAPHICS CORP., an Ohio corporation, ("Grantor") BRANCH BANKING AND TRUST COMPANY ("Grantee").

RECITALS:

WHEREAS, Grantor and Grantee executed and entered into that certain Security Agreement, dated of even date herewith (the "Security Agreement"); and

WHEREAS, Grantor is the owner of the Trademarks and Related Applications listed on Schedule A (collectively, the "Trademarks"); and

WHEREAS, the parties hereto desire to confirm and perfect the security interest (the "Security Interest") granted by Grantor to Grantee in the Trademarks, in accordance with the Security Agreement;

NOW, THEREFORE, subject to the terms, conditions and limitations set forth in the Security Agreement, and in consideration of the mutual covenants, warranties and promises set forth in the Security Agreement, and other good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants and conveys unto Grantee a first lien Security Interest in and to the Trademarks, any applications filed with respect thereto and any Trademarks issued or issuing with respect thereto, such grant being hereby effected for the purposes and subject to the terms, conditions and limitations set forth in the Security Agreement.

Grantor hereby appoints Grantee, with full power of substitution, to file and record this Agreement, to receive any confirmatory documents relating thereto, and to take any and all action before the Patent and Trademark Office to give effect to this Agreement and to the Security Agreement referred to herein.


